

# AGRICULTURAL PRODUCT RULES

1. Farmers must produce at least 90% of all items sold at Lincoln County Small Farmers Market
2. The term Vendor shall all include any family member or employee of the farm.
3. There is no reselling of produce from a wholesaler.
4. Produce that is harvested or collected in the wild is considered as if grown by the vendor, as in mushrooms.
5. Please post signs at your booth that describe varieties and cost of each item .
6. Lincoln county farms will be given first consideration. Out of county farms may not be accepted if there is currently an abundance of a certain product already at the market.
7. LCSFAM reserves the right to visit and inspect your farm for the purpose of determination what produce you are growing. Refusal to permit a farm inspection can result in a suspension from the market and /or termination of vendor privileges.
8. All farms are to have proper documentation and supply the market with current copies. Please send with your application copies of any of the following that apply to you: ODAG scales, ODAG organic registration, ODAG certified kitchen or Oregon Tilth
9. As the market at this time, allows customers to bring their dogs, all produce must be kept at least 20 inches above the pavement. No dogs are to be allowed in produce tents.
10. Meat and poultry must have an ODA license and a USDA Certificate for cut meat.
11. Dairy must be processed in a USDA certified facility.
12. Eggs may be sold without an egg handler license and without labeling, but only by the farm that produces the eggs. Cartons must be labeled with your farm name and contact information..
13. A license is required to extract honey but an exceptions made for operations with less than 20 hives.
14. Scales must be certified by ODA Weights and Measurements and certificate must be displayed.

# NURSERY RULES

1. All nursery products must be grown in Lincoln County.
2. All vendors of live nursery stock with annual sales of \$250 must have a current license issued by ODA.
3. Vendors of live plants may sell plant not grown by themselves as long as they have had said plants at there location for at least 60 days.
4. We reserve the right to conduct nursery visits to determine what plants you are growing. Refusal to permit an inspection may result in suspension or termination of vendor privileges.
5. Please clearly label and price each plant.

# ARTS AND CRAFTS RULES

1. All arts and crafts must be made in Lincoln county.
2. All arts and crafts must be made by the vendor. No reselling is allowed.
3. All arts and crafts will be juryed by a selection committee.
4. If you are new to the market please submit photographs of your products to help the jury with selection. The primary mission of the LCSFAM to support local agriculture and provide a venue for locally grown food and products. We are pleased to include arts and crafts in our market. There may be limited space for crafts but we will try to accommodate all we can.
5. Please list all items you plan to sell at the market on your application.

# FOOD VENDOR RULES

1. Each vendor is responsible for obtaining proper license and insurance and giving a copy to the market.
2. Processed food such as baked goods, dairy product, jams, jellies, salsa , vinegars,oils,dried herbs and dehydrated fruit/vegetables are examples of products that must be processed in an approved kitchens. Food processing certificates that you may need: \*\*domestic kitchen, your kitchen must be inspected by ODA. \*\*Certified kitchen: ODA approved. \*\*Temporary Restaurant license from the county.
3. Hand washing stations for each vendor giving samples.
