Entertainment Application and Agreement

GENERAL INFORMATION

1. Please complete the attached application if you are interested in performing at the LCSFA Market. Mail it to the address above or drop it off at the Information Booth on any Market day. Upon review and approval, the Market Manager will contact you to schedule performances.
2. Performers must reserve dates in advance on a first-come, first-served basis with preference given to any performer who has not previously entertained at the Market.
3. Performances must be appropriate for all ages.
4. Performers must check-in with the Market Manager when they arrive on site.
5. All necessary equipment is to be provided by the performer(s). A canopy may be used (space permitted). Canopies must have a minimum of 25 lbs of weight per leg at all times. Canopies may not be staked.
6. If any electronic enhancement is used it must be kept at a low level so as not to interfere with vendors conducting market business.
7. Performers cannot ask for money but may place a donation basket in one location. Passing of the hat/basket is not permitted.
8. Market Rules apply to all individuals or groups participating at the Market. Please read them before completing and signing this application. The Rules are available on the web site.
